



Welcome to the **Winterfest** event sponsored by the Sloatsburg Chamber of Commerce! This is a family friendly event celebrating the holiday season with community, food, hot beverages, holiday gift shopping, holiday music, and a visit from Santa and Mrs. Claus. The event is scheduled for **December 1st 2018 and will run from 1pm until 6pm.** The event venue will be beautifully decorated with Christmas trees, evergreens, and lights. Two large tents (20' x 40' each) for vendors will be setup with walls and heaters along the Village Walk property owned by Gateway Restoration and Valley Rock Inn and Mountain Club, and adjacent to the Village of Sloatsburg Commuter Lot, 27 Mill Street. Space is capped to 20 vendors and will be filled on a first come, first served basis. **Applications and fees are due by Monday, November 26, 2018.**

The event is rain/snow or shine. If the event is canceled by the Sloatsburg Chamber of Commerce (Sloatsburg Chamber), then vendor fees will be refunded. We are accepting Checks and Cash for the event.

Booth assignments and setup will start at 11:00am. All vendor setup must be completed by 12:45pm. Unless otherwise arranged with the Sloatsburg Chamber, vendors are responsible for set up and tear down and must provide their own tables, displays, and chairs. Tables must be covered and all miscellaneous items and packing materials must be stored out of sight. All trash must be removed and the space left as it was found. *New York State Tax ID is the responsibility of the vendor. Insurance is highly recommended.*

Rental fees for one 5' x 8' booth space (vendor must bring a 6' or smaller table) as follows:
